## **Appointment of Director**

The Board is pleased to announce that Mr. Zou Lei has been appointed as an executive director of the Company with effect from February 11, 2009.

The board of directors (the "Board") of Harbin Power Equipment Company Limited (the "Company") is pleased to announce that pursuant to the authority delegated in the annual general meeting of 2007, the fifth session Board of the Company has resolved to appoint Mr. Zou Lei ("Mr. Zou") as an executive director of the Company with effect from February 11, 2009. His term of office will expire upon the conclusion of the forthcoming general meeting of the Company. The remuneration of Mr. Zou was determined and will be payable by Harbin Power Plant Equipment Group Corporation, the controlling shareholder of the Company. The Company will enter into a service contract with Mr. Zou.

Mr. Zou, 42, graduated from Jia Mu Si Engineering College (佳木斯工学院), Heilongjiang Province, the PRC with a bachelor degree in mechanical design and production. He later received his master degree in business administration from Harbin Institute of Technology. Mr. Zou has profound work experience in the industry of power generation equipment and worked as a dispatcher, the secretary of the party office, the deputy secretary and the secretary of the committee of Chinese Communist Youth League of the general control centre of the production department of Harbin Boiler Company, the secretary of the party branch of 管子一分厂 of Harbin Boiler Company Limited, the manager of Chongrong Factory (重容分厂) of Harbin Boiler Company Limited, the manager of Pingshan Factory (平山分厂) of Harbin Boiler Company Limited as well as the head of production, the deputy general manager, the chairman, the general manager and the deputy secretary of party committee of Harbin Boiler Company Limited. He is currently the standing committee member of the party committee and the general manager of Harbin Power Plant Equipment Group Corporation, the controlling shareholder of the Company.

Mr. Zou has not, currently and in the last three years, held any other directorship in any other listed public company. Save as the aforementioned positions in Harbin Power Plant Equipment Group Corporation, Mr. Zou is not related to any director, senior management, management shareholders, substantial shareholders or controlling shareholder. As at the date of this announcement, Mr. Zou does not have any interest in any share of the Company under Part XV of the Securities and Futures Ordinance.
